Applicability

This document is a Modifyre Event Policy. This document applies to all participants wishing to attend Modifyre.

Purpose

To provide information and guidance on the process and underlying ethos for ticketing for Modifyre.

Summary

Tickets are the key to creating Modifyre. With limited exceptions, everyone buys one, including our Event Production Team. This is in an effort to promote crowd-creation over commercialisation, and is in-line with the ethos of Modifyre and the objects of Burn Arts Inc.

Tickets fund Modifyre. The money raised goes towards essential infrastructure, insurances, permits and grants for art and theme camps. We are almost entirely dependent on ticket revenue to fund the event.

Your ticket purchase is the baseline to participation at Modifyre. There is no free entry for artists and performers, no passes for media, or special discounts for volunteer crew.



1 General Ticket Types

With the exceptions outlined below, every participant buys a full-price ticket to Modifyre.

For Modifyre 2020, we charge a nominal fee. A small portion of this fee is allocated to carbon offsetting, with all remaining proceeds being directed to the Inglewood community.

There are three ticket types this year:

Adults 18+: \$10 + booking fee Children 14-17: \$10 + booking fee Children 13 and under: Free

2 How to Purchase

Tickets can be purchased online via Humanitix:

You will be able to purchase a ticket to the event up until midnight Friday 3 May 2020.

To purchase a ticket you will need to:

- · Register an account on Humanitix
- Complete pre-registration for the event
- Buy your ticket!

Every ticket must be registered in the name of the attending participant. Your ticket will be issued with an ID number that you will use to enter the Modifyre platform.

Name changes are permitted - please email <u>tickets@modifyre.org</u> to change these details.



Please note: On-selling tickets for a higher price than that purchased is strictly prohibited. If this occurs the original ticket will be cancelled and no refund will be provided.

3 Child supervision and adult content

All children must be supervised by a parent or guardian at all times.

Children aged 14-17 will be able to explore the platform individually on their own computer, with the supervision of a parent or guardian.

Children aged 13 and under will be required to pair with their parent or guardian when logging on the website, which will be indicated by the presence of two avatars while exploring the platform

There will be designated 18+ areas on the platform that will be indicated with a sign at the entrance.

4 Terms and Conditions ("T's & C's")

Tickets are sold subject to the Presenter (BURN Arts Inc.–ABN 86 650 321 682) and any third-party vendors 'Terms and Conditions' of sale which are available for review at the time of purchase.

The Terms and Conditions of sale, entry and participants' presence at Modifyre ("**the Event**") include but are not limited to the following:

- The name on the ticket must be your own legal name. BURN Arts inc. has undertaken every endeavour to authenticate users on the Modifyre platform, however BURN Arts Inc. cannot warrant the identity of ticket holders. BURN Arts inc. accepts no liability for a person falsely identifying themself or falsely validating their age when buying a ticket.
- Tickets should not be resold above face value. If a ticket is resold then ownership must be transferred to the purchaser using the ticket transfer system provided by our ticketing vendor Humanitix. Once the transfer is complete the original ticket will not be valid for entry to the event.
- 3. Each participant must buy a ticket, including those cohabiting together.
- 4. All adult ticket holders must certify that they are over 18.
- 5. All children under the age of 18 must have their own ticket.



- 6. Children under the age of 18 may explore the platform with a separate avatar, however they must be supervised by a ticket-holding parent or legal guardian during their participation on the Modifyre platform.
- 7. Children under the age of 13 must be accompanied by a ticket-holding parent or legal guardian at all times. Our platform will have the capacity to login with two people on one computer, with both avatars exploring the platform together.
- 8. ANY RECORDING OR SCREENSHOTS BY THE PARTICIPANTS ARE STRICTLY PROHIBITED AT ALL TIMES. If BURN Arts inc. intends to record any segment of the event, consent will be sought prior to publication.
- 9. BURN Arts Inc. reserves the right to add, withdraw or substitute any elements of the program or vary the advertised event ticket prices or patron capacity.
- 10. Participants must follow the direction of all Moderangers, Digital Operations Team and it's authorised management team at all times.
- 11. Community standards of behaviour are expected and persons deemed to be behaving in a manner that is dangerous or unacceptable will be refused admission and/or removed from the platform.
- 12. YOU KNOWINGLY AND VOLUNTARILY ASSUME ALL RISK OF PROPERTY LOSS, PERSONAL INJURY, SERIOUS INJURY OR DEATH, WHICH MAY OCCUR BY ATTENDING THE EVENT AND HEREBY FOREVER RELEASE, DISCHARGE AND HOLD BURN ARTS INC HARMLESS FROM ANY CLAIM ARISING FROM SUCH RISK, EVEN IF ARISING FROM THE NEGLIGENCE OF MODIFYRE AND/OR ITS AGENTS, AND/OR OR ITS ASSOCIATED BODIES OR BY THIRD PARTIES, AND YOU ASSUME FULL RESPONSIBILITY AND LIABILITY FOR YOUR PARTICIPATION.
- 13. You understand that some participants at the event may engage in expressive activity and dress, which may include partial nudity or nudity and other types of expressive activity. You agree that you have decided to attend the event with full knowledge and that such expressive activity and dress may occur. If you are responsible for the care of any minors at any time during the event, you acknowledge that you have made a choice that the minors may be exposed to the expressive activities and dress that take place at the event, and that you have exercised parental responsibility and control in bringing the minors to the event. Should you find that any activity at the event is offensive to you,or to any minors accompanying you,then you acknowledge that you can avoid such activity by, among other things, leaving the vicinity of the activity, or leaving the event.
- 14. Reading the Survival Guide is mandatory for all attendees.
